Tax Filing Scam Targets Milwaukee County Seniors

According to our friends at the Social Development Commission, which operates our Senior Companion program, many of our seniors believe that they can file tax forms and get a "Economic Stimulus Recovery Rebate" from the IRS. A group of scammers is spreading the word that seniors can file a tax form that will get them hundreds or even thousands of dollars from the IRS. They even advertise in the free papers you can pick up at a gas station.

The scammers promise that for a fee of up to \$300 (paid in cash), they will fill out and file a tax form that will result in an IRS payment. The seniors are assured that they're entitled to a rebate that "very few people know about." After getting their cash payment and the victim's signature, the scammers mail in tax forms to claim tax credits the senior is not entitled to. When that happens, the victims have to pay back the money with penalties and interest..

Worse yet, the scammers have their victim's social security and bank account numbers. With the Social Security printout, they also know when the victim's social security money will be deposited into their bank account.

The SDC believes this problem may be widespread. Many of their Senior Companions say they know of several people who've filed for these rebates. Please help to spread the word about this scam. If you know anyone who has already fallen victim advise them to take some steps to protect themselves from further losses:

1) Notify Social Security that their number may have been stolen

2) Notify their bank that a third party has their account information and ask for a new account number before their bank account is drained.

3) Contact the IRS.





Poverty Among the Elderly

The current official poverty rate does not provide adequate information about who is poor or whether key programs are helping to make progress against poverty, according to the AARP Public Policy Institute.

The current official poverty measure understates persons age 65 or older in poverty, largely because it is based on outdated food consumption patterns and ignores the cost of health care. In 2008, the experimental poverty rate for persons age 65 older was 18.7 percent, which was almost double their current official poverty rate.

A new U.S. poverty measure is sorely needed. The Supplemental Poverty Measure (SPM) that will be produced by the Bureau of the Census in 2011 and the Measuring American Poverty (MAP) Act of 2009 provide significant opportunities to generate a new official poverty measure.

Medicare Update



U.S. Department of Health and Human Ser-

vices Secretary Kathleen Sebelius announced on January 21 that three million Medicare beneficiaries nationwide have received prescription drug cost relief through the Affordable Care Act. To date, three million eligible beneficiaries who fell into the drug coverage gap known as the donut hole during 2010 have been mailed a one-time, tax-free \$250 rebate check.

Eligible beneficiaries who fell into the coverage gap during 2010 are continuing to automatically receive rebate checks. These checks are only the first step in how the Affordable Care Act will reduce prescription drug costs for beneficiaries in the donut hole each year until it is closed in 2020. Starting this year, eligible beneficiaries in the coverage gap will receive a 50-percent discount on covered brand name medications while in the donut hole. In addition, in 2011 Medicare will begin paying 7percent of the price for generic drugs during the coverage gap.

The closing of the donut hole is just one of the ways seniors benefit from the Affordable Care Act. In addition to savings on prescription drugs, the law provides new benefits to Medicare beneficiaries when they visit their doctor starting this year:

* As of January 1, 2011, Original Medicare no longer charges out-of-pocket costs for the "Welcome to Medicare" physical exam and, for the first time since the Medicare program was created in 1965, Original Medicare now covers an annual wellness visit with a participating doctor, also at no cost.

* In addition to these annual wellness visits, most people with Medicare can now receive critical preventive services, including certain cancer screenings such as mammograms and colonoscopies, for free.

* Also this year, the Affordable Care Act will provide qualifying doctors and other health care professionals providing primary care to people on Medicare a 10percent bonus for primary care services. This will help ensure that those primary care providers can continue to be there for Medicare patients.

People with Medicare can learn more about these new benefits, search for participating doctors in their area, and find other helpful information by contacting a trained customer service representative toll-free at 1-800-MEDICARE (1-800-633-4227) or visiting www.Medicare.gov.



Congrats to driver **Neil Arndt**, who recently served his 200th client. What an awesome milestone!


Thank You!


This year I received an early Christmas present from Interfaith. They introduced me to a very interesting lady who can't go out in the cold.
